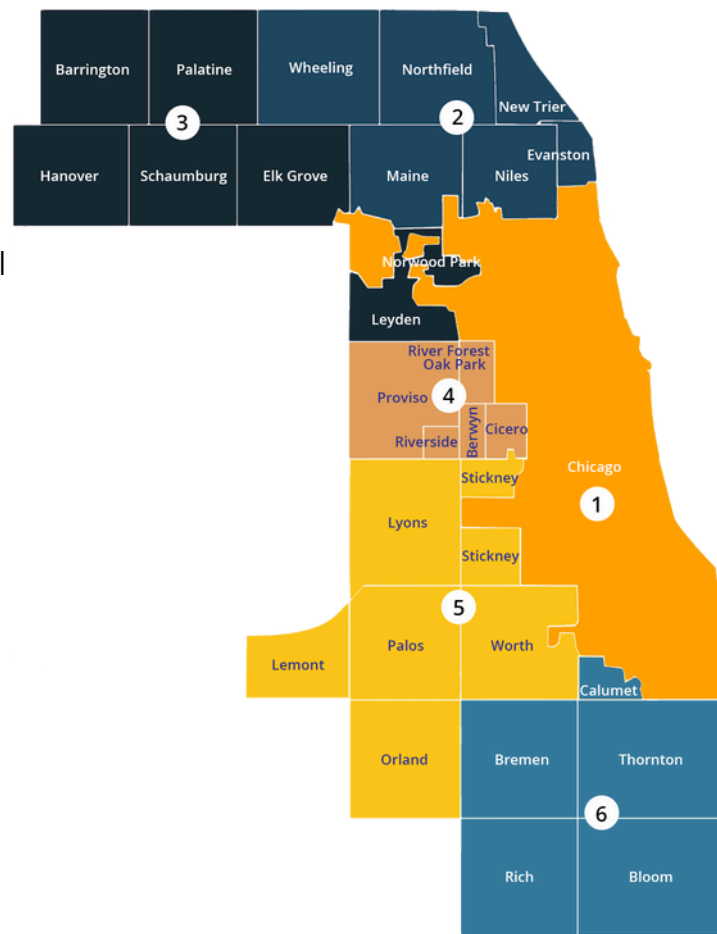

## The following cases are heard in the districts they occurred in:

- Traffic cases
- Civil Cases for damages up to \$100,000
- Criminal cases
- Domestic Relations cases, including petitions for dissolution of marriage, invalidity of marriage, legal separation, joint simplified dissolution of marriage, custody, visitation and civil orders of protection, where at least one of the parties reside within the Suburban Districts.
- Child Support/Parentage cases, where at least one of the parties reside within the Suburban Districts.
- Domestic Violence cases, including orders of protection
- Juvenile Justice cases where the juvenile offense occurred in the Suburban Districts, except for District 4 Maywood.
- Law Division cases in excess of \$100,000. Contact the Law Division at (312) 603-5426 or your local suburban courthouse for details.

## Self Represented Litigants Assistance Information

### District 2

- The Domestic Violence Advocates, located in Room 218, aid domestic violence victims with the filing of Civil Orders of Protection. Call (847) 470-5052 for more information.
- Additionally, through the Chicago Bar Association, the Presiding Judge's Office oversees a Lawyer Referral Program that assists individuals. Call (847) 470-7200 for more information.

### District 3

- Legal Services are available every Friday afternoon at 1:30 PM in front of courtroom 206.
- Court Advocates are available to aid individuals in filing Orders of Protection. They are located in Room 036, and the telephone number is (773) 274-5232.

### District 4

- There are Court Advocates available to aid individuals in filing Orders of Protection, Monday - Friday from 9 AM to 4 PM in room 253.
- Additionally, Bar attorneys are available Monday - Friday afternoons to assist parties in Traffic and Misdemeanor cases.

### District 5

- Volunteer attorneys staff a desk in the lower level of the courthouse on Tuesdays from 9 AM until 12PM.
- Unified Family Court employees, located in room 062 from 8:30 AM to 4:30 AM, aid individuals with completing forms for filing Orders of Protection. For more information, call (708) 974-6265. Court Advocates aid individuals in Criminal matters.

### District 6

- Court advocates are available Monday through Friday from 8:30 AM to 4:30 PM in rooms 101K and 102H and the phone number is (708) 232-4651.
